Situation


When SABIC acquired GE Plastics, the Company left behind its installed HRMS system and its established links to its old payroll providers, data warehouse, and more. As is true in all acquisitions, time was of the essence with tens of thousands of records to be migrated from the old HR platform to a new one, and the same thousands of people to be paid without interruption. Confounding the situation, the global footprint of the company was expansive, and language implications existed as not all countries used single byte/single character languages. Thus, the multi-lingual aspects of the solution were critical.

- Complete system replacement
- Global capabilities in HRMS and Employee Self Service
- Need to link with multiple new payroll service providers in the US, The Netherlands and China
- Technical integration capabilities with downstream business systems and with existing data warehouse
- Turnkey system for company; fast implementation

Solution

Sapien brought global HRMS and Employee Self Service to SABIC. Importantly, Sapien was able to accommodate single byte, double byte and triple byte language characters, providing the single, double or triple storage that these languages, particularly Mandarin, required. This allowed for employees to view screens in English while entering and storing data in their native Mandarin Chinese.



In addition, Sapien built interfaces to three different Benefits providers and to three payroll providers to accommodate US Payroll and separately, to link in to the Ceridian International system in The Netherlands and in China.

Finally, Sapien Human Resources Augmentation™ was included to provide dedicated customer service at the Premium Support level for 120 hours per month. This support initiative, important to most companies but critical for one in transition, proved incredibly valuable to the SABIC team.
